However, it is understood that Ardent Images, LLC respects models' rights to privacy and dignity; if I have any concerns or desired limitations with respect to use of the works from this Shoot because of nudity and/or other reasons, I will discuss them with the Photographer/ Filmmaker in advance and identify any specific intended restrictions in writing in the Agreement.

I agree that I have no rights to the Content, and all rights to the Content belong to the Photographer/Filmmaker and Assigns except as specifically identified in writing in the Agreement. I acknowledge and agree that I have no further right to additional consideration or accounting, and that I will make no further claim for any reason to Photographer/Filmmaker and/or Assigns including claims for libel or invasion of privacy. I acknowledge and agree that this release is binding upon my heirs and assigns. I agree that this release is irrevocable, worldwide and perpetual, and will be governed by the laws (excluding the law of conflicts) of the country/state nearest to the address of the Model (or Parent) given in the Agreement.
